TERMS & CONDITIONS:

1. The work shall be carried out as per CPWD specifications for civil works amended up to date.
2. The material shall be got approved from Engineer-in-Charge, IGNCA/SRC Bangalore.
3. Earnest money of Rs. 13,000/-(Thirteen thousand only)i.e. 2% of Estimated cost shall be deposited along with quotation in the form of demand draft/pay order of scheduled bank in favour of Indira Gandhi National Centre for the Arts, Bangalore and will be kept in separate envelope on top of which will be written “Earnest Money” in bold letters and if found correct, then 2nd envelope of quotation rate will be open.
4. The rate in NIT/Schedule of quantity will be placed in the 2nd sealed envelope with “ rates for Tender Notice No.2.17/12 dated 5th January 2012. In bold letter on top of it.
5. The quotation should be signed and stamped each page and submitted in sealed envelope by the contractor.
6. The IGNCA, reserve the right to reject any or all of the quotations in part or in full without assigning any reason whatsoever thereof. The IGNCA, also does not bind itself to accept the lowest quotation.
7. The Income Tax as per Govt. Rules shall be deducted from the gross amount of contractor bill.
8. The rate should be given in figures and words and rate will be inclusive of all taxes and cartage etc.
9. If there any difference either in figures or in words in the rates quoted the lower of two will be considered
10. Rates quoted shall include clearance of sites both prior to commencement of work and after its completion.
11. All the necessary safety measures shall be taken by the agency in respect of labourers working in the area and it is the responsibility of agency that there shall be not be any damages to the IGNCA/SRC properties.
12. The conditional quotations will not be accepted.
13. The work shall be completed within 60 (Sixty days) days from the date of award of work.
14. The quotation form is available in the office of the Director(Hony.) IGNCA/SRC, Bangalore @ cost of Rs. 200/-each (Rupees Two hundred only) in cash, non refundable amount.
15. The validity period for accepting the tender/quotation shall remain open for 45 days from the date of opening of quotations.

16. The notice can also be viewed on IGNCAs Website www.ignca.nic.in if it is down loaded from website Rs. 200/- will be enclosed with tender form which will not be refunded.
17. The security deposit money @ rate of 5% will be deducted from each bill and will be refunded after six months from the date of completion of work and if no defects are found there.
18. In case of any dispute the decision of Joint Secretary, IGNCAs Delhi will be final & binding.
19. If the work is delayed from due date of completion period fine of Rs. 100/- (Rupees one hundred only) per day will be deducted from the bill .
20. The payment for the work, after submission of the bill by the contractor will be considered as detailed below.
 - (i) 1st running bill (after completion of approximately $\frac{3}{4}$ the of tendered amount) to the tune of 50% only after verification of Engineer, SRC/IGNCA Bangalore.
 - (ii) The 2nd& final bill will be made after completion of all works as per agreement.
